# **Baltic Street West** Public Realm Improvement Proposals

### These proposals form part of Islington's vision to make Islington's public spaces more enjoyable and to foster social cohesion, giving back vehicle-dominated spaces to people.

The proposals as listed below work towards shifting the balance in this space from vehicles to people, whilst still providing alternative arrangements for motorcyclists who currently occupy the provided bays.


#### PROPOSALS

- Relocation of the existing motorcycle bays at Baltic Street West and Crescent Row to existing shared use parking bays located outside 24-26 Baltic Street West.
- A permanent closure of Crescent Row between Baltic Street West and Sycamore Street
- A new raised planter area surrounding the existing tree with seating
- Additional planters located within the new public realm space
- Safe crossing points to and from the new public space
- New paving for the improved space

The council has identified the parking bay spaces outside 24-26 Baltic Street West for the relocation of the motorcycle bays. There is approximately 18m of parking bay spaces here which the council is proposing to provide for motorcyclists as part of the changes. This would also include the provision of lockable facilities for motorcycles.

Vehicles which would usually use Crescent Row would still be able to use Baltic Street West and Sycamore Street to continue on their route, travelling in either direction.
