(Regulation 15(4) The Children (Performance and Activities) (England) Regulations 2014) "Any person who knowingly or recklessly makes any false statement in or in connection with an application for a licence ... shall be liable on summary conviction to a fine not exceeding £1,000, or imprisonment for a term not exceeding three months or both." (Children and Young Persons Act, 1963, Part II, Section 40)
