# **SUBJECT: Review of Polling Districts and Polling Places**

# 1. Synopsis

- 1.1 This report sets out proposed changes to polling districts and polling places
- 1.2 This change will take effect for the Local elections which will be held in May 2022 and all elections for four years thereafter.

### 2. Recommendations

2.1 To agree the changes set out in the report as detailed on the ward maps (Appendices 1 and 2) in relation to the polling districts and polling places for the new wards

### 3. Background

3.1 The Electoral Registration and Administration Act 2013 introduced a change to the timing of compulsory reviews of UK parliamentary polling districts and polling places. The last compulsory review had to be started and completed between 1 October 2018 and 31 January 2020 inclusive.

- 3.2 Since then, the Local Government Boundary Commission has reviewed all of the wards within the London Borough of Islington, which has subsequently seen the number of wards increase from 16 to 17 wards.
- 3.3 These changes have resulted in the need to undertake a review of all of the polling districts and polling places within all of the wards.
- 3.4 The Returning Officers final report will seek agreement from the audit committee of the council which has delegated powers to designate polling places at a meeting of the committee on 5 October 2021.

### 3.5 **Proposed polling districts and polling stations**

#### **Arsenal ward**

Arsenal is a new ward and is mostly made of the districts that used to sit in Highbury West ward which no longer exists following the Local Boundary Review. Part of the old Highbury West ward district NHWA has moved into Finsbury park ward and part of the Highbury West district NHWC has moved into the new Highbury ward.

# **Proposed changes**

With the electorate numbers within Arsenal ward we could have decreased the number of districts to 3 from 5 but because of the shape of the ward and because the Arsenal stadium sits in the centre of the ward we are proposing that 4 districts created as only 3 districts would mean that residents would have to travel around the stadium to get to their polling station.

### **Barnsbury Ward**

Changes to ward lines has meant that Barnsbury ward has absorbed some of Caledonian ward polling district SCAB and has given away part of polling district SBAC to Caledonian ward.

### **Proposed changes**

It is proposed that the streets which have moved into Barnbury ward are split between SBAB and SBAC. Ideally all of the streets would have moved to SBAB but the electorate in that district is already large and close to the maximum for a double station so we are proposing to move some of the streets to SBAC instead, as that polling station is still in close proximity to the streets effected.

It is proposed that we continue to use the same polling stations as previously used as all of the buildings are suitable and accessible and we want to minimise changes to avoid confusion amongst voters.

#### **Bunhill ward**

Due to the predicted increase in electorate projected in Bunhill ward the ward has decreased in size following the Local Government Boundary review so it has lost the majority of SBUC district to the new St Peter's and Canalside ward along with a small number of properties which have moved into Clerkenwell ward.

# **Proposed changes**

Since 2019, Tompion Hall has been undergoing building works so electors in SBUB have been voting at the Islington Museum which is part of Finsbury Library on St John's Street in Clerkenwell ward. Now that the building works at Tompion Hall are complete it is proposed that electors in SBUB go back to using Tompion Hall. It is also proposed that as the SBUC district has decreased so substantially in size that some of the electors from SBUB move to SBUC to equal out numbers in preparation for the predicted increase in electorate within the ward.

#### Caledonian ward

There have been significant changes in Caledonian ward. Half of SCAA along with its designated polling station has moved to the new Laycock ward, part of SCAB has moved to Barnsbury ward and SCAC has absorbed part of the the SBAC district from Barnsbury ward.

# **Proposed changes**

As Westbourne Community Centre now sits in another ward it is proposed that it is replaced by Nailour Hall Community Centre as the designated polling station for SCAA. It is also recommended that the district line remains unchanged. The train tracks create a natural boundary. As SCAC has increased in size it will have to move from a single station to a double station, but unfortunately York Way Community Centre is too small and cannot accommodate this. It is proposed that it is replaced by Hugh Cubitt Community Centre. It is proposed that Jean Stokes remains as the polling station for SCAB but that the Polling District line moves down slightly to the Canal as this creates a more natural boundary.

It is proposed that SCNA and SCNC remain unchanged and SCNB absorbs the streets from St Peter's ward.

It is proposed that the properties from Bunhill ward are moved to SCWB district.

It is proposed that all polling stations remain the same as above.

# **Finsbury Park ward**

Finsbury Park has seen significant change with almost all of NFPB moving to Tollington ward and almost half of the NHWA District from Highbury West ward moving into the ward.

# Highbury

The new Highbury ward consists mainly of the districts which used to sit within the old Highbury East ward which no longer exists following the Local Government Boundary review. Whilst NHEA and NHEB remain unchanged NHEC has lost some streets to Mildmay ward. The new Highbury ward also includes the majority of the NHWC district which used to sit in the old Highbury West ward.

#### Hillrise ward

Hillrise has seen some change following the Local Government Boundary review. While it has gained a small section of the NTOA district and three quarters of the NTOC district from Tollington ward it has lost part of its NHRB district to Junction ward.

### **Proposed Changes**

As the electorate size for Hillrise ward has substantially increased it is proposed that Hillrise increases the number of districts from 3 to 4. It is proposed that NHRA remains the same, as it is already at full capacity for a single station and cannot accommodate a double station. As NHRB loses some streets to Junction ward we think that it should absorb some of the streets from NTOA while the remaining streets should go to NHRC. As NHRB is already a large district we also suggest that some of the streets are moved to NHRC as St Mary's church polling station is closer and easier to travel to for the residents effected. As a consequence of these changes it is also proposed that some of the streets are moved from NHRC to NHRD as the polling station for that district is closer and easier to get to.

# **Holloway**

Holloway has seen a reduction in size with most of SHYC moving to the new Laycock ward while SHYA and SHYB remain unchanged.

Although Holloway has reduced significantly in size it is too large to only have two polling districts so it will need to remain as three districts. As the ward has lost one of its polling stations to Laycock ward it is proposed that SHYA remains unchanged, SHYB absorbs the streets that used to go to Ringcross polling station and that SHYB is then split to create a new polling district.

# **Proposed changes**

There have been significant changes within Tollington ward and the movement of ward lines has meant that it has lost two of the existing polling stations to Hillrise ward. It is for the reason that it is proposed that the NTOB district absorbs the remaining streets left from NTOC, that the district from Finsbury park becomes the new NTOC district and that the new Polling station for NTOA is Cornwallis Adventure Playground. It is also proposed that the district lines between NTOA and NTOC are adjusted slightly to even out the number of electors going to each place.

It is proposed that the small sections of SSMB and SSMC are merged with SSMB and that a few of the existing streets from SSMB are moved to the district absorbed from Holloway Ward as they are closer to Ringcross Community Centre. It is proposed that the section of the ward that was inherited from Caledonian ward becomes a district on its own.

### 4. Implications

### 4.1 Financial implications:

The costs of the polling districts and polling places review will be met from within existing budgets.

# 4.2 Legal Implications:

The Representation of the People Act 1983 section 18B requires that local authorities designate the polling places within their Parliamentary constituencies. Under Representation of the People Act 1983, Returning Officers have the right to use certain public buildings (including schools that receive public funds) for use as polling stations at elections.

Section 18B (4) of the RPA 1983 states that in conducting a review of polling places the authority

- a) seek to ensure that all the electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances
- b) seek to ensure that so far as is reasonable and practicable, the polling places they are responsible for are accessible to all electors, including those who are disabled, and when considering the designation of a polling place, must have regard to the accessibility need disabled persons.

In addition, the polling place for a polling district must be within the area of the district unless s circumstances make it desirable to designate an area either wholly or partly outside of the district.

### **4.4 Resident Impact Assessment:**

The council must, in the exercise of its functions, have due regard to the need to eliminate discrimination, harassment and victimisation, and to advance equality of opportunity, and foster good relations, between those who share a relevant protected characteristic and those who do not share it (section 149 Equality Act 2010). The council has a duty to have due regard to the need to remove or minimise disadvantages, take steps to meet needs, in particular steps to take account of disabled persons' disabilities, and encourage people to participate in public life. The council must have due regard to the need to tackle prejudice and promote understanding.

Electoral Services considered a review of all possible polling places and used a suitability and access checklist. This was drawn largely from the recommendations in Scope's Poll Report 4 published following the 2005 General Election. One checklist has been completed for each existing poll place and all proposed new polling places.

All polling staff receives equalities training as part of the induction for working on the election.

### 5. Reason for recommendations

5.1 Following the Local Government Boundary Review we are required to appoint new polling districts, places and stations.
