Application for New Parent Visitor Vouchers

Free visitors vouchers are issued to all new parents who live in Islington. Vouchers will be issued for the Controlled Parking Zone (CPZ) applicable to the child's home address.

You can apply for the vouchers up to three months prior to, or three months after the birth or adoption of your child. You are entitled to 40 hours of visitor vouchers. The vouchers do not have an expiry date. These vouchers are to be used to allow for parking by midwives, NHS service visits, or by family and friends.

Apply for your vouchers prior to the birth of your child

If you would like to apply for your free visitor vouchers before the birth of your child, you will need to complete an application form, which will need to be signed, dated and stamped by your midwife.

Children registered in Islington

If your child was born in Islington you will need to complete a voucher application form. The free vouchers will be sent to you within two working days on receipt of your full application.

If you do not apply for the vouchers at the time of registering the child you will be required to send a copy of the birth certificate. You have three months from your child's date of birth to apply for your free vouchers.

Children registered outside of Islington

If your child was born and registered outside of the London Borough of Islington you will need to provide a copy of the birth certificate. If your child was adopted you will need to supply a copy of the adoption certificate.

The free resident parking vouchers issued allow the holder to park in a space signed: 'Resident Permit holders only' or in any bay which is shared with a Resident Permit holder. There must also be a sign showing the letter (or letters) that match the zone printed on the voucher. The vouchers are not valid in Business Permit Holders Only, Disabled Parking or Pay and Display bays.
