THE ISLINGTON (20MPH SPEED LIMIT) (NO. *) CONSOLIDATION ORDER 201*

- 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Islington proposes to make the above mentioned Order under Sections 84(1)(a) and (2) to the Road Traffic Regulation Act 1984 as amended.
- 2. The general effect of the 20MPH speed limit Consolidation Order would be to ban any person from driving any motor vehicle at a speed exceeding 20 miles per hour in any public highway in the London Borough of Islington. This applies to any street which lies within and is maintained by the London Borough of Islington.
- 3. The 20 miles per hour speed limit will not apply to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(b) when used in accordance with Regulation 3(5) of those Regulations.
- 4. A copy of the Proposed Order and other documents giving more detailed particulars of the Order are available for inspection during normal office hours until the end of six weeks from the date on which the Order is made or, as the case may be, the Council decides not to make the Order at the following location:
