NOTICE OF VARIATION 2017

PAY AND DISPLAY AND SHARED USE PARKING PLACE TARIFF INCREASES

- 1) NOTICE IS HEREBY GIVEN that the Council of The London Borough of Islington, on 9 March 2017 made the above mentioned Orders under sections 45, 46, 46a, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 to increase the tariff for pay and display and shared use parking places in some locations.
- 2) The general effect of the pay and display and shared use parking place tariff increase will be to increase the tariffs for certain parking places within the London borough of Islington.
- 3) Charges are made for on street parking as a method of regulating demand and controls on length of stay, and enforcement, provide the basis for the Council's restraint policy. In areas where there is greater pressure for parking, a high tariff is appropriate in order to discourage non-essential journeys by car and ensure maximum use of limited spaces. Central Government's Traffic Management and Parking Guidance requires Local Authorities to set charges at levels which help control demand and discourage unnecessary car journeys, particularly car commuting, where there are adequate public transport alternatives. This guidance is reflected in the Council's Parking Plan which includes a policy to provide on-street parking space for visitors at an appropriate tariff, together with meeting residents' parking needs, allowing for loading and unloading goods and the overall restraint objective.
- 4) The classes of vehicles which may be left in the parking places and the times when the parking places operate will remain unchanged.
- 5) The Orders, which will come into force from 13 March 2017, and other documents giving more detailed particulars of the Orders are available for inspection during normal office hours, at the following location:

Any person who wishes to question the validity of any of the Orders, or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made there under has not been complied with in relation to the Orders may make application for the purpose to the High Court by 28 April 2017.
